

Community First Health Plans, Inc. and Community First Insurance Plans Privacy Policy and Terms of Use

By using Community First Health Plans, Inc. and Community First Insurance Plans (Community First) website(s) and/or mobile application(s) (collectively, the "Sites"), you agree to the Privacy Policy, as well as the Terms & Conditions of Use contained therein (collectively referred to as the "Terms of Use").

By accessing and using the Sites, you accept, without limitation or qualification, these Terms of Use. Community First may modify these Terms of Use by revising them on the Sites. Your continued use of the Sites constitutes your acceptance of any such revisions. You should therefore periodically visit this page to review the current Terms of Use. You may not modify these Terms of Use except in a written agreement signed by Community First. The Terms of Use do not address personal information that you provide to us in other contexts (e.g., through a business relationship not handled through the Sites, such as membership in a Community First health plan.) If you are a Member of Community First, please read Community First's applicable Notice of Privacy Practices.

If you do not agree and accept, without limitation or qualification, these Terms of Use, you must exit the Sites immediately.

What Personal Information Do We Collect?

When you visit Community First's Sites, no personal information—such as your name, date of birth or telephone number —is collected, unless you provide us with that information voluntarily, such as when you complete an online form to learn more about Community First's health plans or other products and services. When you provide personal information to Community First, you are responsible for the quality and accuracy of that information. If you choose not to complete a form or provide certain personal information through the Sites, you may not be able to use certain features of the Sites.

How Do We Use Your Personal Information?

If you choose to provide us with personal information by completing a form on the Sites, emailing us, or calling the phone number for agents listed on the Sites, we will use that personal information to (i) respond to your question or request, (ii) communicate with you about our health care plans via email, and (iii) send information to you. Do We Disclose Any Personal Information to Outside Parties?

Unless you expressly give us permission in writing to do so, Community First will not sell, rent, license, or trade your personal information other than as specified in this Privacy Policy.

Disclosures to Third Parties Assisting In Our Operations.

Community First may share your personal information under confidentiality agreements with other companies that work with, or on behalf of, Community First to provide products and services. These companies may use your personal information to assist Community First in its operations. However, these companies do not have any independent right to share this information.

Business Transfers.

We may share your personal information with other business entities in connection with the sale, assignment, merger or other transfer of all or a portion of Community First's business to such business entity. We will require any such successor business entity to honor the terms of the Privacy Policy.

Secure Website Services

Certain online services are available to Community First members via our Secure Website Services, such as <u>CommunityFirstHealthPlans.com</u>, and Secure Mobile Applications (collectively, "Secure Services"). When using such Secure Services, you may disclose personal information to Community First. Community First may collect your personal information for the following:

- The Secure Services require a password to log in before accessing information, thus you may need to provide certain personal information so that Community First may verify your identity;
- To use and share your personal information to provide you with your healthcare benefits or other products and services; and
- To respond to requests via email or any type of communication provided via the Secure Services.

Community First complies with the applicable requirements under the Health Insurance Portability and Accountability Act ("HIPAA"). Users of Community First's Secure Services should read Community First's applicable Notice of Privacy Practices, which explains in more detail how we use and disclose your protected health information ("PHI"). The Notice of Privacy Practices includes information about how to request access to your PHI, how to request an amendment to your PHI, and how to file a privacy complaint. Please refer to the <u>Notice of Privacy</u> <u>Practices</u> for more information.

Community First also complies, as applicable, with other federal and state laws and regulations governing confidentiality and security of your information. Any uses or disclosures of your information will be made in compliance with applicable federal and state law restrictions.

Users of Community First's Secure Services understand that the confidentiality of personal information is protected by federal and state law. By using Community First's Secure Services, you represent to Community First that you are either (i) the individual to whom this account pertains, or (ii) legally authorized under applicable law to receive health care information regarding, and to make healthcare decisions for, the individual to whom this account pertains (for example, as the parent, legal guardian or legal custodian of such individual).

Community First Marketplace Plans

Community First offers Marketplace plans. If you wish to enroll in a Community First Marketplace plan you must complete an enrollment application and provide certain personally identifiable information ("PII"). Your responses on the application will only be used to determine eligibility for health coverage or help paying for coverage. If you do not provide the PII requested in the enrollment application, you will not be enrolled in a Community First Marketplace plan.

As part of the application process, the Marketplace may need to retrieve your information from the Internal Revenue Service (IRS), Social Security, the Department of Homeland Security (DHS), and/or a consumer reporting agency.

The Marketplace needs this information to check your eligibility for coverage and help paying for coverage if you want it and to give you the best service possible. The Marketplace may also check your information at a later time to make sure your information is up to date. The Marketplace will notify you if the Marketplace finds something has changed. The Marketplace will keep your information private as required by law.

Enhanced Direct Enrollment (EDE)

Community First participates as an EDE entity by way of an agreement with the Centers for Medicare and Medicaid Services (CMS), which allows Community First and its authorized EDE partner to submit consumer application information collected directly from consumers to the Federally-facilitated Marketplaces for an eligibility determination, without requiring consumers to submit Marketplace application information through <u>HealthCare.gov</u>. If you choose to apply for coverage through Community First's EDE partner using its website, your activity will also be governed by their security and privacy policies. You may request that we limit the collection, creation, disclosure, access, maintenance, storage and use of your PII

submitted through our EDE partner for the sole purpose of our assisting you in applying for health insurance or obtaining an eligibility determination, facilitating payment for your first premium, assisting you in updating or canceling your enrollment in a health insurance plan, and for performing other authorized functions specified in our agreements with CMS. You may request such a limitation by sending an email to <u>privacy@cfhp.com</u>.

Internet Protocol Addresses

You should also be aware that when you visit our Sites, Community First may collect certain information that does not identify you personally, but provides us with "usage data," such as the number of visitors we receive or what pages are visited most often. This data helps us to analyze and improve the usefulness of the information we provide on these websites.

Cookies and Web Beacons

Like most commercial website owners, we may also use what is known as "cookie" technology. A "cookie" is an element of data that a website can send to your browser when you link to that website. It is not a computer program and has no ability to read data residing on your computer or instruct it to perform any step or function. By assigning a unique data element to each visitor, the website is able to recognize repeat users, track usage patterns and better serve you when you return to that site. The cookie does not extract other information about you, such as your name or address. Most browsers provide a simple procedure that will enable you to control whether you want to receive cookies by notifying you when a website is about to deposit a cookie file.

On some pages of the Sites there may also be use of action tags, sometimes referred to as web beacons or 1x1 pixel graphics interchange format ("GIF") images. Such tags are used to monitor and assess the effectiveness of promotions and marketing. These tags work in combination with cookies, but do not collect or contain any personal information. Community First may use pixels or other online tracking technologies to collect personal information about visitors on certain Sites. This information may include demographic or technical information, and/or web browser data, such as your IP address and browsing behavior. We may also use your information in order to provide information or advertising to those visitors about certain Community First services, benefits plans, and/or provider networks.

Links on the Sites

The Sites may contain links to other websites. Please be aware that Community First is not responsible for the privacy practices of such other websites. When you connect to a website that is linked to our Sites, we encourage you to read the privacy statements of that website. This Privacy Policy applies solely to information



collected by the Sites.

Response to "Do Not Track" Signals

Some Internet browsers include the ability to transmit "Do Not Track" signals. Since uniform standards for "Do Not Track" signals have not yet been adopted, Community First does not process or respond to "Do Not Track" signals.

Children's Privacy Protection

Under Age 18

Minors under 18 years of age who are not Members of a Community First health plan may have the personal information that they have provided to Community First through the Sites deleted by sending an email to <u>privacy@cfhp.com</u> requesting deletion. Please note that, while we make reasonable efforts to comply with such requests, deletion of your personal information does not ensure complete and comprehensive removal of that data from all systems.

Data Retention

Community First retains personal information of visitors to the Sites to the extent required by applicable law, government contracts and in accordance with its data retention and destruction policy. We securely destroy such personal information when applicable retention periods have expired.

Changes to This Privacy Policy

This Privacy Policy may be revised from time to time as we add new features and services, as laws change, and as industry privacy and security best practices evolve. We display an effective date on the policy in the bottom left corner of this Privacy Policy, following the Terms & Conditions of Use, so that it will be easier for you to know when there has been a change. If we make any change to this Privacy Policy regarding use or disclosure of personal information, we will provide advance notice on the Sites. Small changes or changes that do not significantly affect individual privacy interests may be made at any time and without prior notice.

Online Security

Community First uses reasonable and appropriate security measures to safeguard the information that has been collected from you via the public Sites or Secure Services.

Among the measures that Community First has implemented for its websites and mobile applications are administrative, physical and technical safeguards. However, you should know that no website operator, including Community First, can fully eliminate security risks associated with personal information. While Community First has endeavored to create secure and reliable Sites for users, the confidentiality of
